1. Details of the resolutions are set out in the supplemental circular of the Company dated 8 June 2017 (the **Supplemental Circular**). Unless otherwise defined in this supplemental notice, capitalised terms used in this supplemental notice shall have the same meaning as those defined in the Supplemental Circular.
2. A supplemental proxy form (the **Supplemental Proxy Form**) containing the resolutions mentioned above is enclosed with the Supplemental Circular. The proxy form issued by the Company along with the Original Notice (the **Original Proxy Form**) will remain valid and effective if the latter is applicable if correctly completed and lodged with the H Share Registrar of the Company.
3. Shareholders are entitled to appoint one or more proxies to attend the AGM, but only one proxy can be designated to vote at the AGM. For the avoidance of doubt, holders of proxies being appointed to attend the AGM, under each of the Original Proxy Form and/or the Supplemental Proxy Form are different and more than one of the proxies attended the AGM, only the proxy validly appointed under the Original Proxy Form shall be designated to vote on all the resolutions at the AGM.
4. For holders of H Shares, the Supplemental Proxy Form together with the power of attorney or other authorisation document (if any) must be lodged at the H Share Registrar of the Company in Hong Kong, Corner Hare Hong Kong International Service Limited, a 17M Floor, Hope Well Centre, 183 Queen's Road East, Wanchai, Hong Kong in person or by post no later than 24 hours before the time fixed for holding the AGM (i.e. no later than 10:00 a.m., Tuesday, 27 June 2017) or an adjournment hereof (as the case may be). Shareholders can still attend and vote at the AGM upon completion and return of the Supplemental Proxy Form.
5. Please refer to the Original Notice for details in respect of other resolutions to be considered at the AGM, eligible for attending the AGM, proxy, registration procedure, closure of register of members and other relevant matters.
